**Adonis, Marios**, Associate Professor in Clinical Health Psychology, Head of the Department of Social Sciences, University of Nicosia. Dr Adonis is a board member of the Cyprus Mental Health Commission and of the Disciplinary Committee of the Cyprus Psychologists' Registration Council. He has served two terms on the executive council of the Cyprus AntiDrug Council, a term as the National Delegate for the Republic of Cyprus at the United Nations Office on Drugs and Crime, and was the Substitute Member at the Management Board of the European Monitoring Center for Drugs and Drug Addiction for five years. Dr Adonis has also served as the vice president of the Cyprus Psychologists Association for two terms, served a term on the board of the Cyprus Psychologists Registration Council, and represented Cyprus in the Standing Committee on Ethics of the European Federation of Psychological Associations for two terms. He also works as a Clinician and is the Clinical supervisor for a substance dependence rehabilitation center in Cyprus. His research interests include psychosocial and cultural factors in cardiovascular, physical, and mental health, positive psychology, stress, and trauma.

**Vasileia Anaxagorou**, practicing artist and a PhD candidate in Gender Studies at the University of Cyprus. She studied Politics and History at the University of Nottingham and Goldsmiths College, the University of London in the United Kingdom. She was then admitted to the School of Visual Arts in New York City, where she graduated as the top student of her department in BFA Fine Art. She received an MFA in Fine Art (with distinction) from the University of Oxford with the supervision of Katrina Palmer and Oreet Ashery. Vasileia is currently working towards her doctoral research at the University of Cyprus, focusing on the Cypriot feminist subjectivities of performance artists. Anaxagorou's work is interdisciplinary, overlapping in places with moving-image, performance, socially-engaged artworks, photography, painting, drawing, and text-based narratives. Through her work, she continually addresses themes from feminist and queer theory and uses her voice through art-making and research questioning gender representation in societal canons.

**Alexandros Antonaras**, Vice President of Student Services and Associate Professor of Management at the University of Nicosia, Cyprus. He holds a BSc in Mathematics & Statistics with Management (Brunel University, UK), an MSc in Quality Management, and a PhD in Quality & Process Improvement (Cranfield University, UK). He is Chairman of the Cyprus Network for Corporate Social Responsibility (CSR Cyprus) and a Certified Entrepreneurship Facilitator by the Entrepreneurship Learning Initiative (USA). Alexandros is an EFQM Excellence Model Assessor, certified

Project Management Professional (PMP), member of the Project Management Institute (PMI), and a certified VET Trainer by the Cyprus HR Development Authority. Involved in EU-funded initiatives like CSR Matrix and Growing on Ethics, Alexandros has contributed to CSR Europe projects such as EP4Y and CEOs Call to Action. With extensive teaching experience, he has published and presented widely on CSR, sustainability, business ethics, entrepreneurship, and quality management.

**Erica Charalambous**, dance scholar and practitioner specialising in dance digitization, archives, and embodied research methodologies. She completed a cotutelle doctorate at Coventry University's Centre for Dance Research (UK) and Deakin University (Australia), focusing on embodied and oral history approaches to dance archives. Her work explores the organisation, curation, and use of dance archives across Germany, the UK, and Australia, with an emphasis on memory, decolonisation, and ethical practices in dance education. Her research is featured in *Dance Research Journal*, *Journal of Dance and Somatic Practices*, and *Journal for Australasian Drama Studies*. Current projects include the book *Poetics of Dance Encounters* (2024) and collaborations on innovative archiving methods with Cypriot choreographers Lia Haraki, Arianna Economou and embodied ethnographies, family and genealogy storytelling. Bridging academia and practice, Erica engages in workshops, publications, and installations that challenge traditional boundaries in dance studies, cultural practices and how social memory is recorded.

**Kyriakos N. Demetriou**, Regular Member of the Cyprus Academy of Sciences, Letters and Arts and Professor of Political Thought at the University of Cyprus. He specialises in the history of political philosophy and intellectual history, with a focus on classical reception, historiography, and the evolution of democratic theories. He has authored and edited several English-language works (monographs, articles, edited volumes), such as: *Studies on the Reception of Plato and Greek Political Thought in Victorian Britain* (2011), *The European Union in Crisis: Explorations in Representation and Democratic Legitimacy* (2015), *Democracy in Transition: Political Participation in the European Union* (2013). In addition to his publications, he has served as the Executive Editor of *Polis: The Journal for Ancient Greek and Roman Political Thought* from 2002 to 2019. He is also the Founding Series Editor of Brill's 'Companions to Classical Reception' and 'Companions to Classical Philosophy' overseeing scholarly works that explore the impact of classical antiquity on later cultures. Beyond his academic pursuits, Demetriou contributes to the literary world as the author of works that bridge philosophy, literature,

and popular science. His recent book, *H Κρυφή Ζωή των Φιλοσόφων (The Hidden Life of Philosophers, 2024)*, reveals lesser-known aspects of the personal lives of great thinkers.

**Melpo Iacovidou**, Assistant Professor in the School of Business of the University of Nicosia. She holds a Doctorate in Quality Management from Middlesex University, UK, an M.B.A. from Adelphi University, USA (with Distinction) and a B.Sc. in Accounting from Indiana University of Pennsylvania, USA. She has also taught in other private and public universities in Cyprus. Currently she is the Director of the Erasmus+ and NEOLAIa European University Alliance Unit.
