

Charalambous Giorgos, Assistant Professor of Political Science, School of Law, University of Nicosia. Dr Charalambous works in the field of comparative European politics and political sociology and particularly specialising in party politics, political ideologies, mobilisation, political behaviour, the domestic politics of European integration and southern Europe. He is co-coordinator of the BA in European Studies and International Relations. He is the assistant editor of *The Cyprus Review* and co-coordinator of the Communism Specialist Group of the Political Studies Association (PSA), as well as member of the Research Advisory Group for the Leventis Foundation Research and Innovation Programme on Cyprus, at the Hellenic Observatory, LSE.

Christias Athanasios, MJur candidate, University of Oxford, PhD candidate, University of Athens. He is an attorney-at-law, member of the Athens Bar Association. His research interests include civil law, competition law and private international law. He has published on the enforcement of foreign judgments awarding punitive damages and liability of payment service providers.

Christou Odysseas, Assistant Professor in Government, International Law and International Relations in the Department of Law at the University of Nicosia. He has previously taught at the University of Texas at Austin, the Texas Lutheran University, and the University of Cyprus. From 2014 to 2018, he served on the Cyprus Energy Strategy Council appointed by the President of the Republic of Cyprus and tasked with the development of a comprehensive strategic plan for the country's energy policy. His main areas of teaching and research interest are energy, environmental, and climate law and policy at the international, EU, and national levels.
